## Learning outcomes & description

## **DESCRIPTION**

The aim of this module is to outline the knowledge, skills and competences needed to apply the EUAA's structured method of evidence assessment when assessing an application for international protection so that the risk of subjectivity in individual cases is reduced.

Learners will be provided with the knowledge and skills necessary in order to apply the EUAA structured method of Evidence Assessment when assessing an application for international protection. The EUAA evidence assessment methodology builds around three different and distinct steps: gathering information, credibility assessment, risk assessment.

At the end of this module, the learner will be able to:

1. Describe the material facts and the pieces of evidence within an asylum claim according to EUAA structured method of evidence assessment.

Online learning uses learning activities that assess progress toward the learning outcomes and face-to-face sessions focus on complex elements, providing a comprehensive overview of the evidence-assessment methodology.

## **ASSESSMENT STRATEGY**

The final assessment consists of a task where learners evaluate a case study using the EUAA's structured method for evidence assessment in international protection claims. This task accounts for 100% of the final grade and reflects real job responsibilities.
